<sup>2/</sup>This portion of Grogan's Forest pays no MUD tax or Township tax but pays Shenandoah city tax (\$0.1799) and ESD 4 (\$0.1000).

<sup>3/</sup>Creekside Park pays Harris County, ESD 11 (\$0.03606) and Tomball ISD taxes.

<sup>4/</sup>East Shore pays an annual HOA fee varying from \$1,758.00 to \$2,930.00.

<sup>5/</sup>May Valley pays Magnolia ISD tax.

<sup>6/</sup>Town Center pays a Township tax (\$0.2273) plus Town Center Owners Association fee (\$0.18).

<sup>7/</sup>Windsor Lakes, part of the City of Conroe, pays no MUD tax or Township tax. Residents pay Conroe city tax (\$0.4175) plus monthly HOA fee of \$194.00-\$304.00.
