^{2/}This portion of Grogan's Forest pays no MUD tax or Township tax but pays Shenandoah city tax (\$0.1477) and ESD 4 (\$0.0946).

^{3/}Creekside Park® pays Harris County, ESD 11 (\$0.029336) and Tomball ISD taxes.

^{4/}East Shore pays an annual HOA fee varying from \$1,800.00 to \$3,000.00.

^{5/}May Valley pays Magnolia ISD tax.

^{6/}Town Center pays a Township tax (\$0.185) plus Town Center Owners Association fee (\$0.12).

^{7/}Windsor Lakes, part of the City of Conroe, pays no MUD tax or Township tax. Residents pay Conroe city tax (\$0.4272) plus monthly HOA fee of \$208.00-\$328.00.
